

# AccuTrak™ HBV DNA Genotype Qualification Panel 2400-0225

## INTENDED USE

The AccuTrak™ HBV DNA Genotype Qualification Panel 2400-0225 is intended for use by diagnostic manufacturers, researchers, and clinical laboratories to develop, evaluate, or troubleshoot HBV Genotype test methods. Characterized samples and comprehensive data are provided for comparative analysis. For research use only. Not for use in diagnostic procedures.

## PRODUCT DESCRIPTION

This product is a 9-member HBV DNA Genotype Qualification Panel. Positive panel members were formulated by diluting HBV DNA positive plasma samples from various genotypes into HBV DNA negative plasma. The negative member was formulated from HBV DNA negative plasma. Sodium azide (0.09%) was added as a preservative.

## STORAGE

Panel members should be stored frozen at -70 °C or colder. LGC SeraCare recommends that the panel members be divided into smaller aliquots to avoid multiple freeze-thaw cycles, if appropriate. If turbidity or particulate matter is observed, the samples should be centrifuged in accordance with each test kit manufacturer's instructions for sample preparation.

## INTERPRETATION OF RESULTS

The Data Sheet lists results for panel members generated using commercially-available screening, monitoring, and confirmatory test methods. Tests were performed at LGC SeraCare or at recognized reference laboratories (RL) by individuals who routinely use these procedures. Information regarding specific test methods is available on the data sheet. Data Sheets are updated when new data are available.
